Following the publication of statutory notices setting out the County Council's intention to create additional primary places in Winchester through the alteration of the lower age limit and enlargement of The Westgate School the decision has now been taken to proceed. To accommodate the additional pupils detailed plans have been produced in conjunction with the headteacher and governors for which a planning application is due to be submitted next month.

This letter is to seek your views and comments ahead of the proposed planning application to enlarge the premises of the school to accommodate additional primary age students from September 2014. As part of the consultation, a drop in session has been arranged for Monday 26 November from 15:00 until 18:30 in the library at The Westgate School. 
